### Situation

The property is prominently situated in an established industrial area off the B4132 which provides direct access to the A38 (M) some 400 metres to the west. The A38 (M) connects Birmingham to the M6 (J6) and subsequently the M1 and M5. Other occupiers on the estate include Newey & Eyre, Wilts Wholesale Electrical Co, Build Centre, Travis Perkins Trading Co and Screwfix.

### Description

The property comprises a substantial trade counter unit on a site of some 0.38 hectares (0.93 acres) and benefits from a low site coverage of 39%. The property also benefits from two vehicle access-loading doors, integrated office/ancillary accommodation, secure access and an extensive yard. There is an electricity substation on site.


